#### KNOW ALL MEN BY THESE PRESENTS

That we, the undersigned, have this day associated ourselves together for the purpose of forming a non-profit corporation under and pursuant to the laws of the State of Arizona and for that purpose do hereby adopt these Articles of Incorporation

#### ARTICLE

NAME The name of the corporation shall be Experimental Aircraft Association Chapter 81

### ARTICLE II

#### ARTICLE III

PURPOSE. The purpose for which this corporation is organized is the transaction of any or all lawful business for which nonprofit corporations may be incorporated under the laws of the State of Arizona, as they may be amended from time to time

### ARTICLE IV

The character of affairs of the corporation will be: Education about and promotion of sport aviation through public meetings and aviation events.

#### ARTICLE V

No part of the net carring of the corporation shall insure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in uncluding the publishing or distribution of statements,) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 01 (C) of the Internal Revenue Code of fig.
